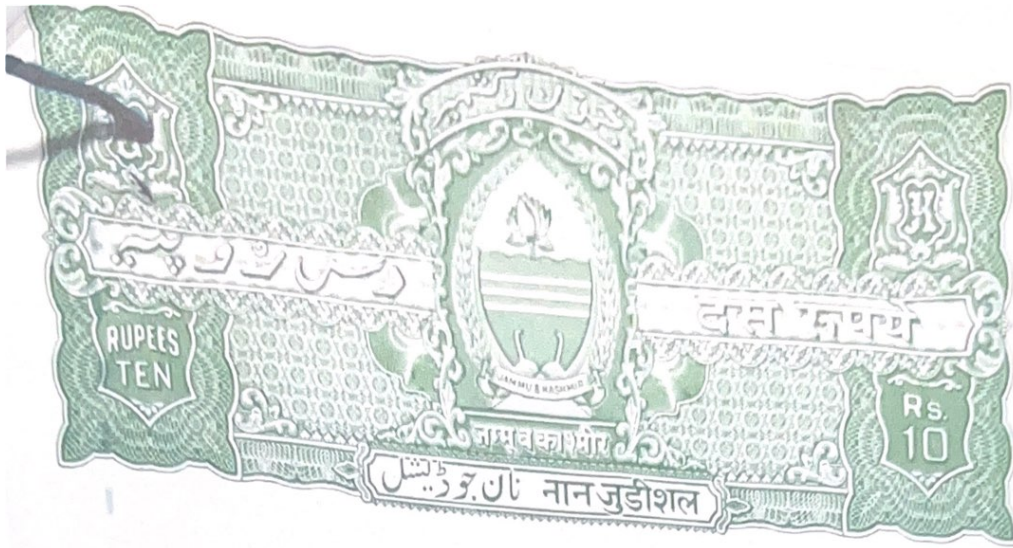

2. That all the trustees including the Settler would form a **Board of Trustees** referred as BOT.

3. That the BOT shall be the supreme body of the trust, all the decisions taken by the trustees in discharge of their duties as such shall be subject to the rectification of the BOT and rectification of the decisions shall be done by consensus or through voting in the event the consensus is not reached. The decisions shall be deemed to have been rectified if it is approved by 2/3rd of the Trustees present and voting.

4. That the BOT shall convene its meeting after every three months for which quorum of 2/3rd of the total number of trustees shall be necessarily present wherein the presence of the 5 trustees namely (1) Mrs. Manisha Choudhary W/O Sh. Subash Choudhary, R/O 1-A Satyam Vihar, Extension Trikuta Nagar, Jammu (2) Vivek Kumar S/O Dr. Jagdish Chander Gupta, R/O Ward No. 13, Shakti Nagar, Dhar Road, Udhampur (3) Suminder Singh S/O S. Mohinder Singh, R/O 13-C, Extn Gandhi Nagar, Jammu & (4) Swaran Singh S/O Sh. Gopal Dass, R/O 200-Sai Kalan, P.O. R.S. Pura, P.S. R.S. Pura Tehsil Distt. Udhampur (J&K) (5) Yash Pal Choudhary S/O Sh. Tara Chand, R/O Rangoor Camp, P.O. & Teh. Ramgarh, Distt. Samba and all the trustees are duty bound to attend each and every meeting of the board.

5. That amongst all the trustees, the trustees shall appoint a Chairman-cum-President, Vice-Chairman-cum-Vice-President, Secretary and a Cashier. Swaran Singh (Cashier) & Yash Pal Choudhary, Advisor shall be must. However, for the purposes of carrying out the purposes/objectives of the Trust, the trustees namely **(1) Mrs. Manisha Choudhary (President)** **(2) Vivek Kumar (Vice-President)** **(3) Suminder Singh (Secretary)** **(4) Swaran Singh (Cashier)** **(5) Yash Pal Choudhary (Advisor)** are nominated as President, Vice-President, Secretary, Cashier and Advisor who shall hold the office initially for a period of one year. Thereafter an election or nominations of the trustees to the posts supra shall be made in accordance with the stipulation made hereinabove.

6. That the Chairman - cum-President, Vice-Chairman-cum-Vice President, Secretary and Cashier shall be the governing body of the Trust.

7. That the governing body of the trust shall in all events be responsible and answerable to the BOT and all the decision taken by the governing body would also require ratification by the BOT in the manner indicated hereinabove.

8. That the Vice-Chairman-cum-Vice-President in absence of Chairman-cum-President, the Secretary or Cashier shall represent the trust before any authority in connection whereof the objectives/purposes of the trust may require.

9. That the Chairman-cum-President shall be responsible to call and arrange the meetings of the BOT and on his failure Vice-President-cum-vice chairman or the Secretary shall be responsible to call and arrange the meetings of the Board in the event of failure in the line of hierarchy.






